### **Annual Meeting News**

The Annual Town Meeting was held on Tuesday, May 4. The Council recommended a budget of \$523,115 in expenditures (based on projected revenues of \$651,718.) The budget was voted on and unanimously approved as proposed. Copies were distributed by mail to residents in April.

In addition to the budget, a vote was held regarding the property tax rate for Section 5. Residents again approved the recommendation of the Council that the tax rate be set at zero.

There were three open Council seats up for election this May, and we had three candidates run for these seats so no voting election was held. All three incumbents Greg Chernack, Patricia Xeller, and Philip Giordano will serve an additional two year term.

### Important Property Tax Bill Information - Please Read

As longtime residents are aware, at the close of each Fiscal Year the Town Council reviews the Section's financial reports and determines whether the Section is able to provide residents with a credit/rebate for that year. This year's vote occurred at the June 8 meeting, and the Council has decided to give each household a \$700 credit. The credit is distributed through a rebate to each resident's upcoming year's property tax bill (these bills will be received by residents in July 2021).



In most cases, property tax payments are made for a resident through a mortgage escrow account. If this is the way you make your payment, there is nothing further you need to do, and you will automatically receive the \$700 rebate.

However, if you pay your property tax bill directly to the County (not through a lender) it is important that you subtract \$700 from the total amount listed on your PAPER BILL. Do not use the amount listed on the online bill. Please refer to the paper bill. This often leads to confusion and possible late fees and penalties.

#### **Home Safety Reminders**

#### Do I Need a Section 5 Permit?

-The majority of renovations
-Sheds or accessory buildings
-Fences - including replacements and/or
substantial repairs
-Driveway projects
-Patio projects
-Right-of-way projects
-Dumpsters or PODS
-Drainage projects including sump
pumps and new downspouts
ALL REQUIRE A PERMIT

Looking to take out a tree?

Most <u>public and private</u> tree removal also REQUIRES a permit.

Please contact the Town office before you begin. We will work with you to make sure you have the necessary information and avoid a costly mishap.

#### Reminder to Dog Owners

Please do not allow dogs to defecate on another resident's private property. The public grass strip (between the sidewalk and the curb) is the appropriate place. Also make sure to place all dog waste in bags and in the appropriate trash receptacle. Recycling bins should not be used for dog waste.

Additionally, dogs should not be allowed to roam off-leash for any reason. Unless your dog is in a designated dog exercise area/dog park, Montgomery County considers a dog at large if it is outside the owner's premise and not leashed. Failure to follow these rules can lead to a \$100-\$500 fine.
