A Message from the Town Council -Annual Election Results

Three of the five seats on the Town Council were up for election this spring. We had six people run for the three spots. This was the first time the Section has had a contested election since 2010. We had a great turn-out with 209 total ballots cast!

The Council would like to thank all the candidates and the residents for their enthusiasm. We also are especially grateful for our dedicated election tellers, Balinda Hinds, Kristina Lowell, and Brooke Thomas for their work in conducting an excellent and organized absentee and in-person election. Incumbent council members, Greg Chernack and Philip Giordano, were re-elected, and Sean Downey was elected as a new member. Our long-time Vice-Chair, Pat Xeller. is retiring from the Council. The Council would like to thank Pat for her many years of superb work. She is a wonderful asset to the Section, and her wise counsel will be greatly missed.

Important Tax Bill Information - PLEASE READ

As longtime residents are aware, at the close of each Fiscal Year the Town Council reviews the Section's financial reports and determines whether the Section is able to provide residents with a credit/rebate for that year. This year's vote occurred at the June 20 meeting, and the Council has decided to give each household a \$700 credit. The credit is distributed through a rebate to each resident's upcoming year's property tax bill (these bills will be received by residents in July 2023).

In most cases, property tax payments are made for a resident through a mortgage escrow account. If this is the way you make your payment, there is nothing further you need to do, and you will automatically receive the \$700 rebate.

However, if you pay your property tax bill directly to the County (not through a lender) it is important that you subtract \$700 from the total amount listed on your PAPER BILL. Do not use the amount listed on the online bill. Please refer to the paper bill. This often leads to confusion and possible late fees and penalties.

Police Officers Offering Summer "House Checks"

Going away for more than a few days? Our Section 5 Police Officers have offered to do courtesy house checks while residents are away for an extended period. Please email the Town



Manager with your address and the period of time you plan to be away. During their regular patrol shift, one of our officers will walk around the perimeter of the house looking for anything out of the ordinary; i.e., open windows or doors, individuals on the premises without authorization, etc.

It is also a great idea to let a neighbor know of your plans so they can keep an eye out for anything unexpected. Residents are also encouraged to stop all newspaper and mail deliveries while you are away.

NO TRASH COLLECTION—JULY 4

Since this year's July 4 holiday occurs on a Tuesday, there will be <u>no trash</u> <u>collection</u> that day.

The regular collection schedule will resume on Wednesday with recycling, followed by trash on Friday.

Council Adopts Ordinance Regarding Possible Purchase of Property

At the June Council meeting, ordinance 4-23-1 was formally voted on and approved. This ordinance gives the Council the authority to move forward with a possible purchase of property at the foot of Windsor Place. While the Council now has the authority to make the purchase, the Council has not yet made a decision on whether to proceed with the purchase.

As background, for some time, the Council has been interested in the possibility of acquiring land in the Section that could be used for a green space for residents. While the Council has been interested in purchasing property, it has proved difficult to find an appropriate parcel, at an acceptable price, that remains available given the often-fast-moving real estate market. To this end, the Section was made aware of a piece of property listed for sale at the foot of the cul de sac on Windsor Place. The property is almost a half-acre of undeveloped land. The land has some environmental restrictions including a small creek that runs across it. The Council is currently working with a land attorney to better understand any easement and usability issues. Depending on this outcome, the Council may submit a contract.

Note: The land purchase ordinance was formally introduced at the April meeting, and full paper copies were mailed to all residents as part of the annual meeting documents in late April.



WSSC Brookville Water Main Replacement Project

WSSC has completed the water main installation in Section 5. Crews are expected to return later this summer to do both concrete repair work and asphalt repaving to the areas that were affected. The contractor would like to do all the repaving work at once. This will mean there will be short periods of time where there is no street parking. If you plan to be away for an extended period of time this summer, and you live in the affected work area, please remember:

- -Please park all of your home's vehicles in your driveway. This is always the best option.
- -If driveway parking is not possible, please consider leaving a key with a trusted neighbor who could move your car if needed.

In December 2020, Section 5 introduced a new composting program in partnership with the Compost Crew. We are happy to report that we now have 70 homes participating. We hope that residents enjoy the service and find it worthwhile, but if for any reason you are not, or you find that you are regularly missing pick up, please consider discontinuing your service so that the Section will no longer be charged. - -Drainage projects, including sump pumps and new downspouts
